The Medical Stores Department through Ministry of Health, Community Development, Gender, Elderly and Children expect to receive funds from the Global Fund towards the cost of supply of laboratory reagents and supplies, and it intends to apply part of the proceeds of this funds to cover eligible payments under the contract for supply of Methadone Assisted Therapy (MAT) commodities for People Who Inject Drugs (PWID) using Framework Agreement.
2. The Medical Stores Department Tender board on behalf of Ministry of Health, Community Development, Gender, Elderly and Children now invites sealed tenders from Eligible Manufacturers for carrying out the supply of laboratory reagents and supplies under framework agreement.
3. Tendering will be conducted through the International Competitive Bidding procedures specified in the Procurement Regulations, 2013 – Government Notice No. 446.
