The Zanzibar Insurance Corporation (ZIC) now invites sealed tenders from eligible **Building Contractors** registered or capable of being registered in **Class Three and above** for carrying out the **Proposed Construction Works for Office Block For Zanzibar Insurance Corporation at Chake Chake - Pemba**.
4. Tendering will be conducted through the **International Competitive Bidding** procedures specified in the Public Procurement (Goods, Works and Disposal of Public Assets by Tender) section 66(1) and is open to all Tenderers as defined in the Regulations.

7. All Tenders must be accompanied by a Tender security in an acceptable form in the amount of **TZS 50,000,000 (Tanzania Shillings Fifty Million Only)**. Tender security shall be a **Bank Guarantee** in the format provided under Section X of the Tendering document from a reputable Bank.
